2. Scope of the Right of Application under Article 11 of the LPPD

The Applicant may apply to Magic Smile and make a request on the following issues:

1) To learn whether their personal data is being processed or not,

2) Request information if personal data has been processed,

3) The purpose of processing personal data and whether they are used in accordance with their purpose learning,

4) To learn the third parties to whom personal data are transferred domestically or abroad,

5) To request correction of personal data in case of incomplete or incorrect processing and to notify third parties to whom personal data are transferred of the transaction made within this scope Don't ask,

6) Although it has been processed in accordance with the provisions of KVKK and other relevant laws, the deletion or destruction of personal data in the event that the reasons requiring the processing of personal data disappear or anonymisation and to request that the transaction made within this scope is personal to request notification to third parties to whom their data are transferred,

7) By analysing the processed data exclusively through automated systems do not object to an unfavourable outcome,

8) In case of damage due to unlawful processing of personal data, the damage demanding that it be remedied.
